Foal Inspection	1-10 months	\$20 (AWR) \$15 (NASPR)	In hand and at liberty. Young foals may be shown at dam's side.	
Branding	12 months & older	\$ 385 (AWR) \$ 215 (NASPR)	No charge for foals branded before 10 months of age at the discretion of inspectors.
