Foal Inspection	1-10 months	\$ 30 (AWR) \$ 30 (NASPR)	In hand and at liberty. Young foals may be shown at dam's side.	
Branding	Over 10 months	\$ 300 (NASPR)	No charge for foals branded before 10 months of age at the discretion of inspectors.
